The proposed correction to the language of the current Bylaws was presented. Specifically, In Article 3 of the Bylaws, change "Article 2" to "Article 1."

Mary Beth made a motion to accept the proposed bylaw correction, Lorraine seconded the motion, and with all in agreement, the motion carried.

Results of Annual Meeting yesterday, it was well attended with engaged participants.

#### Finance - Steve

Steve showed a chart that indicated year long results. LifeRing started out in a difficult position due to the pandemic. The year end fundraiser was much more successful than in years past. Donations brought in \$17,000. Plus LifeRing applied for and received \$11,000 in federal grant funds. It's possible that we may get \$7,000 more but will not find out until later in the summer. LifeRing has over one year of expenses in reserve. An update about review of financial processes was shared.
