APPROVAL OF CONSENT AGENDA

JANUARY 2024 MINUTES

Monica made a motion to approve the minutes. Joe seconded.

VOTE: Sue confirmed unanimous approval.

JANUARY 2024 FINANCIAL REPORT

Joe made a motion to adopt the December 2024 Financial Report. Bobbi seconded.

VOTE: Sue verbally confirmed unanimous approval.

ONGOING BUSINESS

RELATIONS WITH INTERNATIONAL ENTITIES

Mary Beth and Lisa have engaged pro bono counsel Cooley to help make a more formal arrangement with LifeRing's international entities. Cooley has provided a second draft, of the proposed agreement. Lisa and Mary Beth, are adding comments to it and will work with counsel toward finalizing the agreement.

WEBSITE REDESIGN

Robert every other spoke about the working committee for redesign, including Tim, Bobbi, Theresa, and Sue. They are meeting every other week. Sue shared the mock-up for the new front page of the website, which will serve as a template for the new site's landing page. Robert expects the new site to be in development for the next three months.

Sue spoke about the aim for making the site compliant with the Americans with Disabilities Act, especially ensuring that the site is accessible to the blind. Another prominent goal is to display all meeting times in adaptive time zones based on each user's location, rather than the current experience of Pacific Time display.



NEW BUSINESS

2024 BUDGET FORECAST

Joe, the Treasurer and Finance Committee head, presented the 2024 budget. Income is expected to be lower than in 2023, following the assumption that the amount of grant funds we received in 2023 may not be reached. Expenses are expected to increase by 5%, the inflation adjustment that the Finance Committee agreed to. The budget forecasts positive cash flow.

FUNDING REQUESTS PROCEDURES

Joe spoke of how the Finance Committee is streamlining the Funding Request procedure so that it is better aligned with the Income and Expense policy. Both the policy and the procedure will be combined and edited to reflect the current state of accounts and practices.

The new Funding Request procedure should be ready for Board approval in the March meeting.

DEI BOD AWARENESS – DEI INTEGRATION FRAMEWORK AND STAGES

Lisa shared the **DEI Resources** document in chat so that general members attending can view it.

The DEI document originated from the Strategic Planning Committee to raise awareness about various DEI subjects. It's a dynamic list of resources created with the goal of presenting new DEI topics for Board discussion each month. LifeRing leadership wants to publish the document on LifeRing's website, to make it available to convenors and other LifeRing members.

Lisa also requested that anyone who wants to add a new topic to the list send her an email, preferably with one or more resources about the new topic.

REPORTS

TREASURER'S REPORT

Joe shared the January 2024 Treasurer's report. Highlights:

- The report compares January of 2023 and 2024.
- The Percent Change column (% CHANGE) clearly illustrates income/expense differences between the two periods .
- Total Revenue is 26% higher than last year in January.
- Last year's total revenue for January was negative; this year's is positive.
- Graphs also compare the two periods side-by-side.
- Expenses are greater in January of 2024, mostly due to the website redesign costs.



LIFERING BOOK SALES REPORT

Robert produced an ad hoc report on book sales, broken down by book title. Highlights:

- Recovery by Choice remains the most popular title
- LifeRing pays royalties to Marty Nicolaus for two of the titles:
 - o Recovery by Choice
 - o Empowering Your Sober Self
- The other two titles belong solely to LifeRing
 - o How Was Your Week?
 - Humanly Possible
- Book sales spikes in 2021 and 2022 may be attributed to covid pandemic conditions

Sue also mentioned that LifeRing offers a 20% Valentine's discount for book purchases made on February 14, Valentine's Day.

LIFERING DEVELOPMENT REPORT

Sue shared Lorraine's report for January. Highlights:

- Lorraine continues to research more philanthropic family foundations
- Lorraine will prepare a report on how Comeau Foundation funds are spent. She will present the report to Comeau Foundation representative Katie Georgidas.
 - The Comeau Foundation has made fundings of \$20,000 in 2023.
 - LifeRing hopes the spending report will inspire further donations.
- Lorraine is exploring Donor Advised Funds as another option for ongoing donations.
- Two tools for finding foundation grants are being used:
 - o Grant Station
 - Candid (AKA Charity Finder)
- Thanks to Lisa's efforts, LifeRing has a platinum-level classification with Candid/Charity Finder
 - The designation allows LifeRing to display a seal on our website
 - o Donors are more likely to donate to a platinum organization
