Approval Of Consent Agenda

April 2024 Minutes

Monica made a motion to adopt the April minutes as presented. Sue seconded.

VOTE: Sue confirmed a majority vote to adopt, with one abstention.

March 2024 Financial Report

Lisa had raised a question about the Statement of Financial Position during the April meeting.

- The payroll taxes liability varied from the prior year by \$6,000.
- Robert has since investigated and solved the mystery.
 - He had requested extra payroll tax withholding from his paychecks.
 - The withholding had been misclassified in QuickBooks.
 - The extra taxes accumulated as a liability rather than paid to the IRS.
- Robert will have LifeRing pay him the \$6,000 in a check payment to remove the liability.
- The March Financial Report now displays a \$4,500 liability classified as "Robert's \$6,000 payable. April's report has a similar \$1,500 entry, accounting for all \$6,000.

Funding Request: CCAR | MPRC In New Haven, August 2024

Mary Beth requested \$1,500, including LifeRing books, for her attendance, and a table, at the upcoming Connecticut Community for Addiction Recovery Conference, Multiple Pathway of Recovery.

Mary Beth addressed the questions that arose in the last meeting and today:

- 1. Is there a local Connecticut resource who can attend instead of Mary Beth?
 - Local LifeRing members are unable to make the attendance commitment.
- 2. Does CCAR offer a stipend to attendees?
 - At the last event, Mary Beth got a gift card worth \$100 as a keynote speaker. There may or not be something similar this year.
- 3. Is there a return on investment, ie. has this conference given LifeRing a bigger New England presence in the past?
 - o Conference attendees are from regions other than New England.
 - o 30-50 attendees have signed up for the newsletter.



- Books have sold out and personal donations have increased.
- Google stats also show new visitors to the website.

Joe added that the Finance Committee has approved this request.

Joe made a motion to approve the CCAR/MPRC funding request. Bobbi seconded.

VOTE: Sue confirmed a majority vote to approve, with Mary Beth abstaining.

2024 LifeRing Annual Conference

The Annual Conference will be held June 8th and June 9th, from 9am to 2pm PDT. Johann Hari suggested as a keynote speaker

- Mr. Hari is known for a popular Ted Talk where he said "The opposite of addiction is connection".
- He is also a best-selling author of *Chasing the Scream*.
- Although his speaker fee is \$25,000, he has agreed to provide a video address as our keynote speaker, free of charge.

Treasurer's Report

Joe shared the Treasurer's report, with January – April numbers, compared to the same period in 2023. Highlights:

- April saw increases in income from prior months.
- April 2024 income was lower than 2023 income, due to a Comeau foundation donation in 2023.
- Expenses are higher in 2024, attributed to paying the Director of Development
- There was a net profit in April 2024 as opposed to losses in February and March.



LifeRing Development Report

Sue shared Lorraine's Development Director's Report. Highlights: Grant Funding

- Lorraine is working on two grants
- Lisa put together a packet for an Ohio grant
- Fundraisers tried for SAMHSA grant but were unable to meet their requirements
 - SAMHSA Substance Abuse and Mental Health Services Administration, a
 U.S. Department of Health and Human Services agency
 - Tying in relationships with hospitals, RCOs (recovery community organizations), and IOP (intensive outpatient programs)s may help get future SAMHSA grants
- Fundraisers also trying for grants from
 - o Mutual of America Community Fund
 - Comeau Foundation (have contributed before)

LifeRing Book Sales Report

Robert presented YTD book sales numbers. Highlights:

- Sales lower in April
- Discussion regarding whether count of books sold aligns with book revenues in the Financial Report.
