## LifeRing Officers and Chair

#### **Executive Director**

At last month's meeting the Board promoted Sue from Interim Executive Director to Executive Director.

#### **Board Chair**

**VOTE:** Sue confirmed a majority vote to keep Sue as the Board Chair. Sue abstained.

#### Treasurer

Sue had nominated Monica Foy as Treasurer. Njon seconded.

#### Secretary

Ewa, who was not present, had expressed an interest in being secretary, but has not committed to it. After asking if anyone present wanted to nominate or volunteer, and deciding against electing Ewa in absentia, the matter was tabled.

## Treasurer's Report

Monica clarified the data presented. Highlights:

- We had a positive cash flow in June
- Year-to-date cash flow is negative
- Per the Financial report, the Statement of Financial Position for June indicates that assets exceed liabilities for a positive equity balance.

## LifeRing Book Sales Report

Robert shared the year-to-date book sales report, by month. Highlights:

- 237 copies of Empowering Your Sober Self
- 270 copies of Recovery by Choice
- 57 copies of *How Was Your Week?*
- 44 copies of *Humanly Possible*
- Second guarter sales are down but there is little data as to why.
- Totals include sales through Amazon and LifeRing Bookstore.
- Royalties for most books currently go to Martin Nicolaus but will be bequeathed to LifeRing.
- The Fundraising/Marketing/Communications committee may consider a book sale.

## **LifeRing Teams Updates**

#### Social Media

Bobbi was absent, but Sue spoke about Facebook

- The old Facebook page has been migrated to the new Facebook page.
- All attendees are encouraged to interact with the new page.

## LifeRing Teams Projects Report

### **Regional Representatives**

Lisa shared the status of the Regional Reps team. At Robert's request, she spoke about Regional Reps' duties.

- The Regional Reps quarterly meeting will be held later in July.
- Regional Reps serve as a go-between for the Board and the convenors in each region.
- They help new convenors start meetings and provide guidance for all convenors.
- They ensure that all public meeting information is up to date.



### Fundraising, Marketing, and Communications Team

Sue shared a graphic of the donations received year-to-date, compared with last year.

- This year's numbers exceed last year's YTD donations.
- YTD donations are over \$20,000.
- There is a meeting attendee who attends multiple meetings, then donates a dollar for each meeting attended, via the online donation portal, at the end of each month.
- Everyone is encouraged to join the FMC team and/or contribute fundraising ideas.

**VOTE:** Sue verbally confirmed unanimous approval to adjourn. The meeting adjourned at 9:55 AM.



## LifeRing Public Forum

### Taresa questions

#### Regional Reps

What are the eligibility requirements to be a regional rep? How does a person express interest and get assigned?

**Lisa:** The eligibility requirement is six months of sobriety, just as it is for convenors

How do we identify when a new region needs to be separated and set up with a representative?

Lisa: Regional reps are usually the ones that identify new regions

#### Conference Feedback

How do we collect, assess, and choose to act on feedback from surveys and the conference? What are we doing with the feedback we received? How is it documented? What's the process for getting it approved to work on? Who gets assigned to work on it? I assume the Board evaluates what we should and should not pursue.

**Sue**: The Board does not usually respond directly to feedback, but it's handled team-by-team. For example, there was feedback that 10pm meetings require more Board oversight, and that was brought to the Online Regional Rep. It will be discussed in the next Convenor's meeting.

- Disciplinary issues come to the Board for handling.
- Most feedback is routed to the appropriate team.

#### Committees

Are there metrics that the committees are tracking that show how they're advancing toward our strategic goals, and can we review those each board meeting?

Are quantifiable goals being set and is progress being measured? For example, I'm on the website committee, I don't know if we made a commitment to a target date for going live. Or, is what gets reported this month different from what was reported last month? What is our goal as a committee?

Could committee reports give us 1) a sense of what they planned to do last month, 2) what they accomplished toward that plan, and 3) what they plan to complete next month?

A discussion ensued with input from Njon, Lisa, Robert, Sue, Anna, and Laura. Topics included:

- Practices and protocols, both past and present
- The Team Status Report
- Volunteer motivation and retention
- Board representation on teams



#### Committees, continued

What are the requirements (like sober time?) to lead a committee? What's the mechanism to express interest and get selected? Are there requirements for length of service or term limits?

More discussion. Highlights:

- Committee recruitment
- Encouraging meeting attendance for committees and the monthly Board meeting
- Shifting membership on the Board as well as committees
- The challenge of meeting bombers
- Asking for donations of volunteer time vs. money
- Leveraging social media
