Treasurer's Report

Monica presents the income and expenditure information in its new visual graph form. November was a good month with a significant increase in assets.

Monica suggests that it may be useful to pursue a monthly donor base, or "sustaining members" in order to have more steady income over the year. The Finance committee is working on end-of-the-year tax planning and Monica will be trialing Quickbooks' budget forecasting tool.

Sue adds that there is a new feature on Zoom, a pop-up that includes a dedicated donor page as people leave the meeting. The pop-up provides a QR code individuals can click on which takes them directly to the donor page. It also tracks all donations coming through online meetings and provides the opportunity for people to sign up as recurring or sustaining donors. Sue reports that overall fundraising increased by 5.4% YTD over the past year.

Lorraine has recruited several LifeRing members to write appeals for donations on a twice weekly basis through the month of December.

The Fundraising/Marketing/Communications committee continues to meet on a weekly basis.
