Treasurer's Report

Monica presents the income and expenditure information in its new visual graph form. December was a good month with continued significant increase in assets in comparison to last year.

Donations from meetings have declined since so many in-person meetings remain closed post-pandemic. Book sales continue to be robust and overall, 2024 income was greater than 2024 expenses. Monica reports that she is working on establishing a budget for 2025.

LifeRing Fundraising and Development Report

Lorraine reports that LifeRing raised more in donations in 2024 compared to the previous year with an overall 6% increase over the past four years. Thank you to all Board members for their generous support.

LifeRing Development Report

FMC Committee has been meeting on a weekly basis since October 2024.

Lorraine reports that she will be meeting with Katie Georgitis and her brothers (Comeau Foundation) for lunch on December 25th which will provide an opportunity to share LifeRing's progress.

Lorraine continues with her ongoing search for other secular minded philanthropic organizations for grant funding opportunities.

She has also continued to attend webinars on grant writing: and it will be important to be aware of how the 2024 election may potentially affect grants/fundraising in 2025 and advising diversification in fundraising strategies.

Lorraine also reports that she and Sue had a renewal call with Steven Samra, who is LifeRing's technical assistance representative from SPARK at SAMHSA.

Steven informed them that LifeRing now appears in SAMHSA's resource tools, and he appeared to be more engaged with what LifeRing has to offer, perhaps partly related to recent changes in LifeRing's competition along with the fact that LifeRing remains steadfastly abstinence-based. It is notable that LifeRing will be celebrating its 28th year anniversary and that it has been operating solely on donor contributions for that long.

Lorraine and Sue will be meeting with Steve again tomorrow and he has invited a marketing specialist named Christina to join the meeting. Christina will assist with LifeRing's website and social media posts and will be a good resource according to Steve.

Lorraine had a call with Fidelity Charitable to begin setting up Donor Advised Fund (DAF) using Fidelity's widget to create a giving option on Lifering's website.

Also Charles Schwab has a similar program and she will be working with the Finance Committee on building out the framework to support DAF donations.

Lorraine reports that LifeRing has received the final notice of non-selection from One Ohio Recovery Foundation who included information about webinars for future grant writing opportunities in Ohio.
